RULES:

1. **CONTESTANTS MUST PAY AN ENTRY FEE OF \$40.00. ENTRY FEE MUST ACCOMPANY REGISTRATION FORM AND IS NON-REFUNDABLE.**
ENTRIES SHOULD BE FILED NO LATER THAN 12:00 NOON AUGUST 5TH, or until maximum in each class is reached. EACH DIVISION IS LIMITED TO 25.
2. A QUEEN AND FOUR RUNNERS-UP WILL BE CHOSEN IN EACH AGE DIVISION. QUEENS WILL RECEIVE A BEAUTIFUL TROPHY, CROWN, AND WRAP AROUND SASH. ALL OTHER CONTESTANTS WILL RECEIVE A NICE TROPHY. THE 2010 TITLE HOLDERS WILL CROWN THE 2011 WINNERS AND WILL **NOT** BE ELIGIBLE TO COMPETE IN THE LITTLE MISS PAGEANT THE FOLLOWING YEAR.

WEE MISS - DIVISION I: 2- 3 YEARS

TINY MISS - DIVISION II: 4-5 YEARS

LITTLE MISS - DIVISION III: 6-9 YEARS

LITTLE MISS PRE-TEEN - DIVISION IV: 10-12 YEARS

TEEN MISS - DIVISION V: 13-15 YEARS

3. CONTESTANT MAY WEAR A DRESS OF HER CHOICE.
4. CONTESTANTS WILL BE JUDGED ON BEAUTY (75%), AND PERSONALITY (25%).
(JUDGES SCORE SHEETS WILL NOT BE AVAILABLE TO CONTESTANTS)
5. THE FAIR RESERVES THE RIGHT TO REQUIRE PROOF OF AGE UPON REQUEST.
6. ALL PARTICIPANTS MUST ABIDE BY THE GUIDELINES SET UP BY THE PAGEANT COMMITTEE.
7. FIRST PLACE WINNERS WILL NOT BE ELIGIBLE TO COMPETE AGAIN IN THE DIVISION IN WHICH THEY WON.
8. THE 2010 QUEENS MUST CROWN THE 2011 WINNERS AND ARE NOT ELIGIBLE TO COMPETE IN 2010.
9. PLACEMENT OF AGE GROUPS WILL BE MADE BASED ON THE AGE AT THE TIME OF CONTEST.
