

### Entry & Security

-  All items brought onto the fairgrounds are subject to search by security personnel.
-  The Appalachian Fair reserves the right to deny entry to any person or item deemed unsafe by Appalachian Fair Security Officials or the Washington County Sheriff's Department.






### Prohibited & Restricted Items

-  Selfie sticks
-  Backpacks (discouraged)
-  Firearms or weapons of any kind
-  Outside food & beverages (including coolers) – *Exceptions may be made for guests with special dietary needs, baby food, or infant formula*
-  Alcoholic beverages or illegal drugs
-  Tobacco products – *discouraged and strictly not allowed in barns or seating areas*
-  Umbrellas – *not allowed in concert or seating areas*
-  Camping/tailgating chairs – not allowed
-  Pets – *not permitted at any time unless part of an authorized show/exhibit. Only **trained service dogs** assisting guests with disabilities are permitted. Service animals must remain under control, on a **leash or harness at all times.***
-  Drones/motorized aircraft systems – prohibited above or near the fairgrounds unless prior permission is obtained from fair management, in accordance with FAA regulations.




### Weather Policy

-  The Appalachian Fair is a rain or shine event, including all concerts and attractions.
-  No rainchecks or refunds will be issued.
-  Severe weather warnings within 5 miles (as issued by the National Weather Service) will trigger immediate public address or media announcements directing guests to seek shelter.
-  Designated shelters: Farm & Home Building ♦ Building 1 ♦ Building 3 ♦ Building 4 ♦ Appalachian Heritage Museum ♦ Show Barn
-  Concerts or events may be delayed, postponed, or canceled depending on severity and duration of weather.

### Conduct & Attire

-  Shirt and  shoes are required at all times.
-  Appropriate, family-friendly attire is expected.
-  Open-toed shoes are not permitted on certain rides (*see Drew Exposition ride requirements online*).
-  Guests displaying inappropriate or disruptive behavior will be removed from the fairgrounds.

### Soliciting & Promotions

-  Unauthorized soliciting, selling, distribution of materials, or promotion of other events/organizations is strictly prohibited.
-  Unauthorized posting of signs, banners, or handbills is not allowed on the grounds, parking areas, or fencing.
-  All sales and promotional activities must be pre-approved by Appalachian Fair Management.

### 🚫 Admission, Tickets & Re-Entry

- 🚫 No re-entry: Hand stamps are not used. Guests must purchase a new ticket to re-enter once leaving.
- 🎫 Tickets must be purchased **only** through the **Appalachian Fair website** or the **official Box Office**. *Third-party tickets are not guaranteed* and will not be honored. *Scammers charging more than our advertised prices (\$10-\$25) should be avoided.*
- 🚫 Lost or stolen tickets are the responsibility of the purchaser.
- ⌚ All tickets, coupons, and passes become void after the last day of the event.

- 📷 The Appalachian Fair and Washington County Sheriff's Office encourage parents to photograph their child/children before entering, in case of separation.

Welcome, exhibitors! 🐄 🐑 🐷 To keep everyone safe and ensure a smooth, enjoyable experience, please review these important guidelines before fair week.

 **Entry Deadline:** August 3. Exhibitors must notify the Appalachian Fair Office of the **number of livestock** being entered, including the **department, class, and lot** for each animal, **before the entry deadline**.

- 🐄 **Stabling cannot be guaranteed** unless requests are received by that date.
- ⚠️ **Late entries** are subject to penalties, resulting in **double entry fees**.
- 📄 All exhibitors must comply with the **Tennessee Department of Agriculture Rules & Regulations**, the **Appalachian Fair General Rules**, and the **specific breed rules** listed under each department/class.
- 🚫 The Appalachian Fair reserves the right to **bar any animal or exhibitor** that does not meet the required breed standards.

#### **Bedding:**

- 🐄 **Beef exhibitors:** Bedding included in entry fee.
- 🐄 **Dairy & Sheep exhibitors:** Must provide own bedding.
- 🚫 **Grooming chutes** are not allowed in the line-up area or main aisles.

#### **Health & Identification:**


- No animal will be allowed on the grounds **without current health papers** and a **legible tattoo or flock identification number** attached to the ear.
- 🔍 Identification is subject to inspection by the **Livestock Committee** or other fair officials.

#### **Junior Exhibitors:**

- Must be **unmarried and under 21 years of age**. Exhibitors must not have reached their **21<sup>st</sup> birthday on or before show day**.
- Must be able to **exhibit their animal without assistance**.


#### **Feed & Vehicle Rules:**

- 📄 Only a **one-day supply** of feed and hay is allowed in the barn.
- 🕒 Feed and hay may be delivered **before the fair opens** each day.
- 🚚 **Vehicles must be moved to Lot 3 immediately after unloading**.
- ⚠️ For safety, no vehicle movement should occur during fair hours.
- 🚗 All vehicles must be parked in **Lot 3 by 2:00pm** or risk being **towed at the owner's expense**.

 **Pets:** **Dogs are not allowed** on the fairgrounds during open hours. Please leave pets at home. 🏠

#### **Pre-Registration & Payment:**

- Livestock exhibitors must pre-register and pay **by midnight on August 3**.
- Entry forms may be **submitted online, faxed, or emailed**.
- 💰 Fees must accompany the entry, either **hand-delivered with a check** or **paid online** through the invoicing system.

 **Washing Areas:** All livestock must be washed in **designated areas only**. 💧

#### **Entry Fees:**

- 🐄 **Beef:** \$15 per head (includes bedding) – applies to both Open & Junior entries. \$15 per extra tie-space.
- 🐄 **Dairy:** \$7 per head and extra tie-space.
- 🐑 **Sheep:**
  - Open Sheep - \$5 per head / \$10 per extra pen / Jackpot - \$25 per head
  - Junior Sheep - \$2 per head
- ⌚ **Late Fees:** All entry fees are **doubled after midnight, August 3**.

#### **Exhibitor Passes:**

- One (1) pass issued **free per exhibitor (12 years of age and older attending the animal in the showing) or farm**. All others must pay regular Fair admission (\$10) or purchase a Fair pass.
- Additional 3-day Livestock Exhibitor passes may be purchased for **\$10 each** (limit 8 per farm).
- 👶 **Children under 12 do not require an entrance pass**; therefore, Livestock Exhibitor passes will not be issued.

#### **Parking:**

- Each farm receives **one loading/unloading pass** and up to **two Lot 3 parking passes**. Additional available upon request.

#### **Judges:**

- Judges will be selected by the **Livestock Committee** and **Board of Directors**.
- Exhibitor suggestions for future judges are welcome.

- Animals must be **owned by the exhibitor** and **registered**.

- **Cattle:** A breed with fewer than 2 exhibitors/farms and 5 animals – shown as **AOB** (All Other Breeds) or class canceled.
- **Sheep:** A breed with fewer than 2 exhibitors/farms and 10 animals – shown as **AOB** until numbers increase.

## Premium Checks:

- Available at dismissal when possible.
- If unavailable, checks may be **picked up at the Fair Office beginning August 31** or **mailed after September 8**.

## Barn Cleanliness:

- Aisles must be **cleaned daily before 3:00pm** and **maintained during fair hours**.
- Hours: 3:00-10:00pm (Mon-Fri) / 10:00am-10:00pm (Sat)

## Herdsman Awards:

- Presented at the end of each Open and Junior Show for Beef, Dairy, and Sheep. 🏆 Winners receive **\$60**.
- Judged on: Orderliness, Cleanliness, Arrangement, Appearance, and Rule Observance.

## Supreme Champions:

- Chosen at the conclusion of each Open and Junior shows (Beef, Dairy, Sheep). 🏆 Winners receive a **premium award**, sponsored by **Farm Credit Services of Mid-America/Rural 1<sup>st</sup>**, and a **banner** sponsored by the **Daniel Boone FFA Alumni**.

## Tie-Space & Stalling:

- Assigned based on number of entries. Tie-beside preferences must be noted at the time of registration.
- 🐑 **Sheep stalling:** 3 lambs, 3 rams, or 2 yearlings per pen; additional pens may be reserved.
- 🚫 Unauthorized relocation of signs or space assignments may result in **disqualification**.

## Designated Wash Areas: All livestock must be washed in assigned locations only. 💧

## Beef Arrival, Check-In, Tie-Out, & Dismissal:

- **Open Beef Cattle:** Admitted Sunday, August 23; in place by **12 Noon Monday, August 24**.
- **Junior Beef & Dairy Steers:** Admitted Sunday, August 23, before **5:00pm**.
- **Junior Beef Exhibitors** must register with the Livestock Chairperson by **5:00pm Sunday, August 23**.
- 🏴 **Weight-based animals** must be weighed by **5:00pm Sunday**.
- 🕒 **Tie-Out Time:** All cattle must remain in the barns until **8:30pm**.
- 🕒 Dismissal time assigned after completion of shows. Early dismissal only with Livestock Chairperson approval.
- 🚫 **Early departures** forfeit all premium money.

## Dairy Admission, Milking Parlor, and Dismissal:

- **Open & Junior Dairy Cattle Check-In:** Gate 3, between **2:00am-12Noon, Thursday, August 27**.
- 🐄 **Milking Parlor:** Operation subject to approval by the **Tennessee State Veterinarian**. If closed, exhibitors of lactating cows must bring personal milking equipment.
- 🕒 **Dairy Dismissal:** Assigned after Dairy Show on **Saturday, August 29**. Early departures forfeit premium money.

## Sheep Admission & Dismissal:

- **Open Sheep Admission:** Gate 2, **2:00am-12Noon, Thursday, August 27**. Animals must be checked in 3:00-6:00pm.
- 🏴 **Jackpot Animals** will be weighed **3:00-6:00pm on Thursday, August 27**.
- **Junior Sheep Admission:** Gate 2, **2:00am-12Noon, Friday, August 28**. Animals must be checked in 3:00-6:00pm
- 🏴 **Market Lambs** will be weighed **3:00-6:00pm on Friday, August 28**.
- 🏠 **Tents:** Limited and marked spaces available – Tents in wash rack area **not allowed prior to 12Noon on Thursday, August 27, or after 6:30pm on Saturday, August 29** to allow trailers to use the alley for loading and unloading.

**MEMORANDUM**

TO: Fair Officials, Rodeo, Livestock and Poultry Exhibition or Show Managers  
FROM: Samantha Beaty, DVM  
State Veterinarian  
DATE: February 9, 2026

Enclosed is a summary of Tennessee regulations and health requirements for livestock and poultry at fair shows, exhibitions, other shows and rodeos.

Special Comments:

1. It is expected that all exhibitors bring only healthy animals to fairs and exhibitions. Although state and federal animal health officials will be performing as many inspections as possible, **fair officials are responsible** for ensuring that all animals entering fairs for exhibition are in overall good health and are accompanied by a Certificate of Veterinary Inspection. Animals showing clinical signs of contagious disease should be sent home immediately. Violations should be reported to the state veterinarian or her agent.
2. Certificate(s) of Veterinary Inspection (CVI) are to accompany all animal(s) to the respective shows with the exception of in-state Tennessee equine and poultry. In-state Tennessee equine six (6) months of age and older must have a negative Equine Infectious Anemia test within the preceding twelve (12) months. Poultry assembled at shows or exhibitions should be accompanied by evidence of a negative test for Pullorum-Typhoid within 90 days or **be tested on-site prior to exhibition following strict biosecurity procedures** or originate directly from a flock which has been certified as Pullorum-Typhoid Clean under the Tennessee Poultry Improvement Plan. As part of increased awareness and surveillance for Avian Influenza and other poultry diseases, the physical appearance of all birds should be assessed at the time testing is conducted.
3. Certificates of Veterinary Inspection issued in satisfaction of these Tennessee Fair Regulations shall be good for **90** days for Tennessee livestock only.
4. Certificates of Veterinary Inspection demonstrate that the animal showed no signs of contagious disease at the time of veterinary exam and CVI issuance. Animals developing signs of disease after inspection but during the period the CVI is valid are still subject to rules refusing entry of animals with contagious diseases to exhibitions and shows.
5. Please note that exhibition requirements for out-of-state livestock are the same as regular import requirements.
6. **Warts, ringworm, scabies, contagious ecthyma (sore mouth), foot rot, cutaneous fungal and bacterial infections (i.e. club lamb disease, caseous lymphadenitis, pink eye/conjunctivitis) are considered contagious and infectious diseases and are NOT permissible.**
7. **All out-of-state poultry must originate directly from a Pullorum-Typhoid Clean Flock and a H5/H7 Avian Influenza Clean Flock or be accompanied by evidence of a negative Pullorum-Typhoid test within ninety (90) days and a negative official Avian Influenza test within twenty-one (21) days.**

**Also, please note that if highly pathogenic avian influenza is detected in Tennessee or a neighboring state, commingling of poultry at fairs and exhibitions may be suspended.**

**Fair Biosecurity**

Below is a summary of recommendations for fair management by the National Assembly of State Animal Health Officials and the National Association of State Public Health Veterinarians to better protect fair attendees from disease:

- Provide easy access to hand washing stations.
- Post informational signage that includes the following messages:
  - No eating or drinking in the animal areas.
  - Wash hands frequently.
  - No pacifiers, sipping cups or strollers in the animal exhibition areas.
- Discourage sleeping in the animal exhibition areas.
- If human or swine influenza-like-illness is associated with the exhibition, animal health and public health officials should be notified immediately.
- People who have influenza-like illness should leave the exhibition immediately and seek medical care. They should advise their health care provider about their fair attendance.
- People at high risk for developing severe complications from influenza should limit their exposure to swine.

Also, be aware of the potential exposure of fair attendees to Salmonella and E. coli 0157 from animals exhibited on the fairgrounds.

**April 27, 2026 Update** from the TN Dept of Agriculture Commissioner, Deputy Commissioner, and State Veterinarian:

- 1) Please be sure and spread the word that just like Swine and Poultry, **if any animal in a group of animals that haul in together is sick with a contagious illness the whole load will be disqualified and asked to leave.**
- 2) The Certificate of Veterinary Inspection (CVI) is a traceability document and will not guarantee that an animal will be free of lesions 30 or even 90 days after the CVI is issued. Animal owners should be checking their animals daily and should consult with their veterinarian for care and treatment. Animals with contagious illness should remain at home and NOT be brought to the show. If you think it is contagious, it probably is... LEAVE IT.
- 3) Animal Health Field staff members are available to pre-screen at your farm if you are unsure. Call our main office to schedule a visit.

### **Accepted Official Identification Types by Species for Fairs/Exhibition**

*Animals being imported from out of state must meet import requirements*

Bovine: -840 RFID tag or; -USDA Metal tag (if placed before November 5, 2024) or; -Registration Tattoo – Registration papers must be submitted with the CVI to our office and must travel with the animal to exhibitions with their CVI or; -Sufficient description to identify each animal individually\*\*\*

Swine:-USDA metal tag or; -840 RFID tag or; -Registration Tattoo – Registration papers must be submitted with the CVI to our office and must travel with the animal to exhibitions with their CVI or; -Ear Notches – Registration papers must be submitted with the CVI to our office and must travel with the animal to exhibitions with their CVI or; -Sufficient description to identify each animal individually\*\*\*

Sheep and Goats: -Scrapie Tag or; -Registration Tattoo – Registration papers must be submitted with the CVI to our office and must travel with the animal to exhibitions with their CVI or; -Electronic Implant – Registration papers must be submitted with the CVI to our office and must travel with the animal to exhibitions with their CVI. Owner must have a reader for scanning the implant on request.

\*\*\*Sufficient Description to Identify each Animal – *Animal should have obvious unique identifiers including markings or scars that would make the animal distinguishable from all other animals of the same sex and species regardless of age. This is only applicable to Tennessee origin animals shown at Tennessee fairs.*

## **TENNESSEE DEPARTMENT OF AGRICULTURE DIVISION OF ANIMAL HEALTH**

### **SUMMARY: LIVESTOCK HEALTH REQUIREMENTS FOR FAIRS AND EXHIBITIONS**

#### **I. GENERAL**

- A. All stalls, pens, chutes, etc. located on the grounds of fairs and exhibitions shall be thoroughly cleaned and disinfected with a disinfectant approved by USDA, APHIS between each scheduled fair or exhibition.
- B. All livestock (except poultry and equine) which enter fairs and exhibitions shall be accompanied by an official Certificate of Veterinary Inspection with individual permanent identification. Certificates for this purpose shall be valid for ninety (90) days from date of issue. (Tennessee livestock only – out-of-state certificates are valid for thirty (30) days from the date of issue.)
- C. **No animal showing clinical signs of infections or communicable disease shall be allowed to enter or remain on premises of fairs or exhibitions. It shall be the responsibility of the manager of each event to assure prompt removal of such animals.**

#### **II. LIVESTOCK AND POULTRY ORIGINATING WITHIN THE STATE OF TENNESSEE**

[Certificates of Veterinary Inspection Valid for a Period of Ninety (90) Days]

- A. **SWINE:** All swine which enter fairs and exhibitions shall be accompanied by an official Certificate of Veterinary Inspection with individual permanent identification or sufficient description to identify each animal.
- B. **CATTLE:** All cattle which enter fairs and exhibitions shall be accompanied by an official Certificate of Veterinary Inspection with individual permanent, official identification. **Lactating Dairy Cattle residing within Tennessee and moving to an exhibition, show, or sale within Tennessee (interstate movement) do not require pre-movement H5N1 testing.**
- C. **POULTRY:** (1) Sponsor of poultry shows or exhibitions shall notify the Tennessee Department of Agriculture at least **thirty (30) days prior to show or exhibition.** (2) Poultry found not to be in apparent good health shall be removed immediately from any show or exhibition.
- D. **HORSES & OTHER EQUIDAE:** Horses and other Equidae six (6) months of age and older must have a negative Equine Infectious Anemia test within the preceding twelve (12) months.

- E. SHEEP: (1) All sheep imported into or through Tennessee shall be accompanied by an official Certificate of Veterinary Inspection and be in compliance with 0080-2-1-.02, and Title 9, Code of Federal Regulations, Part 79.1 through 79.4. (2) All sheep that move within the state, with the exception of wethers under the age of 18 months that are produced for slaughter only, including for change of ownership, shows, fairs, expositions, or slaughter shall be permanently, individually identified by a method approved in Title 9, Code of Federal Regulations, Part 79.1 through 79.4.
- F. GOATS: (1) Goats imported into or through Tennessee shall be accompanied by an official Certificate of Veterinary Inspection and be in compliance with 0080-2-1-.02, and Title 9, Code of Federal Regulations, Part 79.1 through 79.4. (2) Goats imported into Tennessee for immediate slaughter to an approved slaughter establishment or to an approved livestock market for sale to a slaughter establishment shall only be required to have a transportation document and be in compliance with Title 9, Code of Federal Regulations, Part 79.1 through 79.4. (3) All registered breeding goats, goats that have been commingled with sheep, goats for exhibition and dairy goats that move within the state, including for change of ownership, shows, fairs, exposition, or slaughter shall be permanently, individually identified by a method approved in Title 9, Code of Federal Regulation, Part 79.1 through 79.4.
- G. CAMELIDS: Camelids must have an official Certificate of Veterinary Inspection as provided in Rule 0080-2-3-.01(1).
- H. CAPTIVE CERVIDAE: Captive Cervidae must have an official Certificate of Veterinary Inspection as provided in Rule 0080-2-3-.01(1). (1) CWD susceptible species must have two forms of identification (including official USDA ID). (2) CWD susceptible species must not move from a CWD affected County to a non-CWD affected County.

### III. LIVESTOCK AND POULTRY ORIGINATING OUTSIDE THE STATE OF TENNESSEE

Livestock and Poultry entering fairs and exhibitions from areas outside the State of Tennessee shall be subject to current Tennessee import requirements. Please contact the state veterinarian's office regarding questions or recent changes to these rules. These interstate requirements are summarized as follows:

- A. ALL SPECIES (except poultry): Official Certificate of Veterinary Inspection valid for thirty (30) days and individual permanent official identification, except for equine. Equine must have sufficient description to identify the animal.
- B. CATTLE: Certificate of Veterinary Inspection and additional requirements as follows: (1) Tuberculosis: No requirements except for cattle originating from regions not considered free of tuberculosis. (2) Brucellosis: No requirements except for cattle originating from regions not considered free of brucellosis. Test eligible cattle – Intact male or female cattle eighteen (18) months or older. (Vaccinates and non-vaccinates). (3) **Per the USDA Federal Order, all lactating dairy cattle originating outside the State of Tennessee must have a negative H5N1 test within seven (7) days of interstate movement. Lactating dairy cattle can move back to the state of origin within ten (10) days of test.**
- C. SWINE: No testing requirements for swine unless originating from a region not considered free of Brucellosis and Pseudorabies.
- D. HORSES AND OTHER EQUINES: Animals six (6) months of age or older – negative equine infectious anemia (Coggins) test within twelve (12) months.
- E. POULTRY: Originate directly from a Pullorum-Typhoid Clean Flock and an H5/H7 Avian Influenza Clean Flock or be accompanied by evidence of a negative Pullorum-Typhoid test within ninety (90) days and a negative Avian Influenza test within twenty-one (21) days.
- F. SHEEP: (1) All sheep imported into or through Tennessee shall be accompanied by an official Certificate of Veterinary Inspection and be in compliance with 0080-2-1-.02, and Title 9, Code of Federal Regulations, Part 79.1 through 79.4. (2) All sheep that move within the state, including for change of ownership, shows, fairs, expositions, or slaughter shall be permanently individually identified by a method approved in Title 9, Code of Federal Regulations, Part 79.1 through 79.4.
- G. GOATS: (1) Goats imported into or through Tennessee shall be accompanied by an official Certificate of Veterinary Inspection and be in compliance with 0080-2-1-.02, and Title 9, Code of Federal Regulations, Part 79.1 through 79.4. (2) Goats imported into Tennessee for immediate slaughter to an approved slaughter establishment or to an approved livestock market for sale to a slaughter establishment shall only be required to have a transportation document and be in compliance with Title 9, Code of Federal Regulations, Part 79.1 through 79.4. (3) All registered breeding goats, goats that have been commingled with sheep, goats for exhibition and dairy goats that move within the state, including for change of ownership, shows, fairs, expositions, or slaughter shall be permanently, individually identified by a method approved in Title 9, code of Federal Regulations, Part 79.1 through 79.4.
- H. CAMELIDAE: Same requirements as for cattle.
- I. CERVIDAE: Certificate of Veterinary Inspection and additional requirements as follows: (1) Brucellosis: Same requirements as for cattle. (2) Tuberculosis: (a) All cervidae shall originate in herds which have had a negative herd test for tuberculosis within twelve (12) months with a USDA approved single cervical test and individual imported animals shall be negative to the single cervical test within thirty (30) days of entry; or (b) Animals not originating in tested herds as described above must test negative to two (2) single cervical tests at least ninety (90) days apart, the second test conducted not more than thirty (30) days prior to entry. (3) Two forms of identification (including official USDA official ID). (4) CWD: (a) CWD susceptible species must be from a CWD Certified Herd.

NOTE: (Contact an accredited veterinarian for further details of import rules).

- IV. Fair association or exhibition or management shall inform exhibitors of the rules of this chapter and shall notify the State Veterinarian or her agent of any violations. Exhibitors shall present evidence of compliance with this chapter to the State Veterinarian or her agent upon request. These rules constitute a minimum legal standard and in no way restrict the right of fair and exhibition managers to establish additional or more stringent requirements.

## Recommendations for Exhibitors of Lactating Dairy Cows Related to H5N1/Avian Influenza of Dairy Cattle

Adapted from USDA APHIS Guidance (May 2024)

### Before the Event

- Become familiar with requirements for interstate movement as well as any state specific exhibition requirements prior to the event.
  - Rules and Regulations Governing Movement and Handling of Livestock at Fairs and Exhibitions
  - Federal Order Requiring Testing for and Reporting of Highly Pathogenic Avian Influenza (HPAI) in Livestock
  - APHIS strongly recommends minimizing movement of lactating dairy cattle as much as possible, with special attention to evaluating risk and factoring that risk into movement decisions.
    - Consult with your veterinarian to discuss risk.
  - Lactating dairy cattle moving interstate to an exhibition, show, or sale must have a negative test result from samples collected within 7 days of movement. These animals may travel to their home herd using the same negative test result provided the exhibition, show, or sale does not exceed 10 days of length.
  - **Lactating Dairy Cattle residing within Tennessee and moving to an exhibition, show, or sale within Tennessee (intrastate movement) do not require pre-movement testing.**
- Become familiar with signs of influenza in cattle and work with your veterinarian to ensure your animals are free of illness.
  - Signs of influenza in dairy cattle include decreased milk production; reduced appetite; thickened, discolored milk; lethargy; fever; and/or dehydration.
  - If you have any animals with clinical signs on the premises, do not move other animals off the premises.
- Ensure that any people that will be attending the fair or exhibition do not have any symptoms of illness.
- Clean and disinfect any equipment you will be bringing with you to the exhibition such as:
  - Feed equipment
  - Cleaning utensils
  - Grooming equipment
  - Vehicle and Trailer (inside and out)
  - Portable milking equipment
  - Use approved disinfectants that are safe for human and animal contact: <https://www.epa.gov/pesticide-registration/list-m-registered-antimicrobial-products-label-claims-avian-influenza>
- Avoid transporting animals from different premises in the same trailer.

### During the Event

- Keep copies of certificates of veterinary inspection (CVIs), vaccination records, and test results on hand and readily available.
- Observe cattle regularly for signs of influenza-like illness (e.g. decreased milk production; reduced appetite; thickened, discolored milk; lethargy; fever; and/or dehydration).
  - Report sick cattle to the show veterinarian and exhibition organizers.
- Sick animals should be immediately removed from the exhibition or moved to a designated temporary isolation area. Sick lactating dairy cattle can be evaluated on site before leaving the premises OR can be sent home and state animal health officials and your veterinarian should be contacted for follow up testing.
  - Interaction with the sick animal should be limited to only people caring for the animal.
  - Dedicated personal protective equipment (PPE) such as disposable gloves, gown/coveralls, and boots or boot covers should be worn by people caring for sick animals.
  - No treatment supplies, feed or water, portable milking equipment and supplies, or grooming supplies should be shared between sick animals and healthy animals.
  - Additional precautions should be taken by those caring for sick animals to minimize the opportunity for disease transmission to other cattle or people. Precautions could include hand washing before putting on and after taking off PPE, changing clothes and changing boots between activities.
- Follow the event's biosecurity plan. Avoid close contact with other exhibitors' animals and avoid nose-to-nose contact between animals.
- Follow the event guidance for handling milk from lactating cows.
- Do not share tools, feed and water, portable milking equipment and supplies, or grooming supplies with other exhibitors.

### After the Event

- Isolate and observe animals daily for illness after returning home and before allowing contact with other animals.
  - 30-day isolation of lactating dairy cattle from other livestock is recommended.
  - Do not share equipment between show cattle and other animals at home.
- Discuss the need to test animals returning from an exhibition or fair for influenza A with your veterinarian.
- Consult your state or local public health department if exhibitors or family members develop influenza-like illness (e.g., fever or chills, cough, sore throat, runny or stuffy nose, muscle or body aches, headaches, tiredness, and/or vomiting and diarrhea) or conjunctivitis (red eyes) following the event. Testing and treatment for influenza A may be available. The TN Dept of Health can be reached at 615-741-7247 (24/7).
- Clean and disinfect all equipment you took to the show.

**Eligibility & Premium Participation**

- Only registered Angus cattle meeting the age requirements in this classification are eligible for premiums and counted in the total head shown. Champion and Reserve Champion placings are not included in the head count.
- The American Angus Association (AAA), 3201 Fredrick Avenue, St. Joseph, MO, participates in premium payments for Open Angus Breeding Cattle based on the number of head shown. The AAA premium assistance supplements, not replace, the premiums offered by the Appalachian Fair and are included in payments distributed to exhibitors.
- A minimum of 50 head must be shown in the Open Class Division to receive AAA premium participation for the following year. The 2025 Open Angus Show total was 29 head; therefore, the 2026 show will not receive AAA premium assistance. Exhibitors must follow all AAA Rules as outlined in the *Breeders Reference Guide: Part 2 - Association Rules (Rule 800 Series, Rules 800-810)* found at [www.angus.org](http://www.angus.org).

**Cow/Calf Eligibility:** Any female that qualifies for female classes/lots under the Association's classifications may not compete in cow/calf lots. The calf at side is eligible to show in its respective class/lot. Females shown with calves must have: Their most recent natural calf (no more than 280 days old on show day) ▪ Calf registered and proof of registration available at check-in.

**Registration & Identification:** Exhibitors must have the original registration certificate or current AAA pedigree proof of ownership at check-in. All animals must display a legible, permanent ID mark (tattoo, freeze brand, or hot brand) matching the registration certificate. Animals with incorrect or unreadable identification marks are ineligible to show and cannot be re-tattooed or rechecked at the event.

**Handling & Show Conduct:** Only one person may lead an animal in the show ring at any given time. Altering the appearance or conformation of an animal for exhibition is strictly prohibited. This includes: ▪ Chin straps or devices altering head carriage ▪ Covering white skin ▪ False tail heads or false hair (except for tail switches) ▪ Graphite, powders, hemp, or similar external products ▪ Illegal or unlicensed pharmaceuticals, steroids, or artificial fillers. Any animal found in violation will be barred from competition.

**Aerosols & Line-Up Area:** No aerosol cans or pressurized containers are permitted in the designated line-up area.

**Enforcement:** Authorized representatives of the American Angus Association (AAA) or the Appalachian Fair have full authority to enforce all rules. Violations of either AAA Rules or Fair Regulations may result in the animal being disqualified or barred from competition.

**Lot Size & Show Organization:** Any lot exceeding 15 head must be divided into smaller lots. Divisions should be made as evenly as possible without separating animals of the same birth date. Lot divisions are at the discretion of Show Directors and must comply with AAA regulations.

**Championships & Awards:** Grand and Reserve Grand Champion Cow/Calf Pairs do not compete for Grand Champion Female and are ineligible for the Get-of-Sire, Junior Get-of-Sire, and Breeder's Six Head lots. At the conclusion of all open competitions: ▪ A Supreme Champion Female and a Supreme Champion Bull will be selected from all Open Show breeds Grand Champion winners. They will each receive a banner and a **\$500 Premium Award**. ▪ An Open Show Herdsman Award will be presented for outstanding care, presentation, and showmanship.

**Eligibility & Registration:** All cattle entered in this class must be registered with the American Simmental Association (ASA). Original registration papers must accompany all animals at the time of check-in. All animals entered in individual female and bull lots must be born on or before May 31, 2026. All cattle must be dehorned. Any animal with a legible tattoo or firebrand number will be ineligible and barred from showing.

**EPD Data & Weigh-In:** The most current Expected Progeny Differences (EPDs) for all entries will be collected at check-in. All cattle will be weighed at check-in. Judge(s) will have access to each animal's EPDs and corresponding Percentile Ranks from ASA, which will be used in conjunction with visual appraisal in accordance with PTP Guidelines.

**Health & Breeding Requirements:** All bulls 15 months of age and older must have a current semen test/breeding soundness exam and show to be a satisfactory breeder. ▪ The test must be conducted within 60 days prior to the show date. ▪ All bulls 12 months of age or older must be shown with a nose lead or ring. ▪ All females 18 months of age or older must provide one of the following certifications: ▪ (a) A statement from a licensed, non-owner veterinarian verifying pregnancy, or ▪ (b) Certification verifying that she has been used in embryo transfer. ▪ Documentation must be provided prior to check-in for the animal to be eligible to show.

**Eligibility & Registration:** All animals entered in the Open Charolais Breeding Classes must be **purebred and registered** with the American-International Charolais Association (AICA). Only bona fide, original certificates of registration will be accepted as proof of registration and ownership. Animals registered in the AICA Colored Division Registry must be the requirements of the AICA Color Card.

**Animal Examination & Presentation:** All animals are subject to a **medical examination** to verify age and must be shown in their natural conformation without alteration or modification. Refer to AICA Article XV, Paragraph B, Point 2: ▪ The use of artificial tailheads is not permitted. ▪ The use of coloring agents, flock, or powder is prohibited. ▪ Any animal lacking a legible tattoo or firebrand number will be ineligible and barred from showing.

**Semen Test Requirement:** Bulls entered in **Classes 38, 39, 42, & 43** must have a valid, satisfactory semen test certificate in possession. This certificate is valid for the entire show season.

**Weaning & Cow/Calf Eligibility:** All animals exhibited in individual lots must be weaned, except for Cow/Calf Lots in which calves are at the side of females calved after September 1, 2025. ▪ The calf at side must be purebred and registered with the AICA. ▪ Females calved before September 1, 2024 must compete in the appropriate individual female lot based on age. ▪ Nurse cows are not permitted.

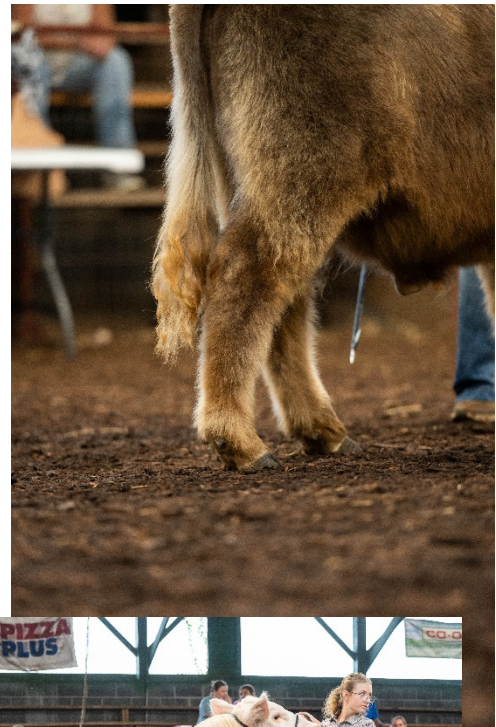

**Junior Beef Show Exhibitor Rules & Information ~ A Century of Family, Farming, and Fun**

**Eligibility:** Junior Show Exhibitors include anyone who can exhibit their animal without assistance, is unmarried, and is 21 years of age or younger as of the day of the show. The Junior Beef Show is open to out-of-state exhibitors who also meet these eligibility requirements.

**Entry Procedures & Deadlines:** Entry forms for the Junior Beef Show are available in this catalog or on the Fair's website at [www.appalachianfair.com](http://www.appalachianfair.com). Entry forms may be completed online or delivered to the Fair Office prior to the entry deadline of August 3. All fees must accompany the pre-registration forms, either by 1) Hand-delivering entries with a check, or 2) Paying online through the invoice issued at the time of registration. Junior Show-only exhibitors must also provide payment for bedding at the time of entry. Unpaid fees and entries submitted after the deadline date will result in **double entry fees**.

**Showmanship & Animal Handling:** Exhibitors must show their own animal unless: ▪ The exhibitor has more than one animal in the same lot, or ▪ Has an approved absence by the committee chairperson. In such cases, a substitute show person may be used but must also be a junior member as defined above. Only one person at a time is permitted to lead animals into the show ring.

**Registration & Ownership:** All animals entered in the Junior Beef Show must be registered in the name of the junior exhibitor or transferred to that junior by July 1 prior to the show. Proper registration papers or transfer certificates must be presented to the show chairperson when cattle arrive at the fairgrounds. Lease contracts will be accepted if: ▪ They are presented at the time of entry, and ▪ Were legally executed on or before July 1 prior to the show. Exhibitors leasing animals must show proof of lease at check-in.

**Health & Arrival Requirements:** All cattle exhibited in the Junior Division must meet the health requirements set forth by the Division of Animal Disease Control. Cattle must be in place and registered with the Livestock Director before 5:00pm on Sunday, August 23. The Appalachian Fair reserves the right to bar any animal or exhibitor not meeting these requirements.

**Dress Code:** Exhibitors must be properly dressed while showing. ▪ Shirts must be tucked in. ▪ Jeans or slacks are required. ▪ Boots are strongly recommended in the show ring.

**Feed & Housing:** Feed must be furnished by the exhibitor, and all animals must be kept in their assigned space. Space will not be provided for nurse cows.

**Breed Representation:** If a breed has fewer than two (2) exhibitors and five (5) animals registered, those animals will be shown in the Any Other Breed (AOB) division.

**General Compliance:** Entry into any class or lot of this show binds the exhibitor to all regulations and requirements pertaining to the event. Exhibitors must comply with the rules and health regulations of: ▪ The Tennessee Department of Agriculture ▪ Their respective Breed Association ▪ The General Rules of the Appalachian Fair as outlined in this catalog.

**Junior Angus Exhibitor Rules & Information:**

**Premium Participation:** The American Angus Association (AAA) will participate in premiums offered in individual classes for Junior Angus entries, as included in its standard show classifications. Premiums are paid according to the AAA premium schedule, which is based on the number of head shown. The premium assistance provided by the American Angus Association is in addition to the premiums offered by the Appalachian Fair and will be included in premium payments distributed by the show.

**Minimum Participation Requirement:** A minimum of 15 head must be shown in the Junior Angus Heifer Lots to receive AAA premium participation. The show is not required to include all lots to qualify for premiums. *In 2025, a total of 20 head were exhibited;* therefore, AAA premium assistance will be received for 2026 as shown above.

**Eligibility:** Exhibitors in levels 1-5 include anyone who can exhibit their animal without assistance, is unmarried, and meets the age requirements of their lot division as of the day of the show. The Beef Showmanship Competition is open to out-of-state exhibitors who also meet these eligibility requirements. Exhibitors must show their own animal, and the animal must be registered and shown in one of the Beef Show class/lots. If the animal is leased, proof of the leasing agreement must be presented at the time of check-in.

**County Groups:** Must consist of five (5) animals (any breed) owned by five (5) different 4-H or FFA members from a county. Judges will place each group, and all groups deemed worthy will receive a cash reward.

**Compliance & Health Regulations:** Exhibitors are subject to all rules and health regulations of: ▪ The Tennessee Department of Agriculture, and ▪ The Appalachian Fair Association as set forth in this catalog.

### Livestock Senior Showmanship Scholarship Award:

**Scholarship Overview:** The first-place winner in the Senior Showmanship Division will be eligible for a scholarship award of \$1,000. This scholarship is designed to recognize outstanding youth in livestock exhibition and to support their continued education in agriculture and related fields.

**Eligibility & Claim Requirements:** The scholarship must be claimed within two (2) years of the recipient's high school graduation. **Open Dairy Show Rules & Information ~ A Century of Family, Farming, and Fun**

**Show Procedure:** The Appalachian Fair will host a *One-Day Dairy Show*. The *Junior and Open Shows* will be held simultaneously. Each class or lot will be judged and placed as an Open Show division. Following the Open Show placings, Junior Show exhibitors will be invited to pull forward and receive their Junior Show awards. Therefore, any exhibitor participating in the Junior Show must be the individual exhibiting the animal.

**Eligibility:** No animal may be entered or exhibited unless properly recorded in the recognized herd book of its respective breed association. Exhibitors must produce an official *Certificate of Registry* upon request by the department chairperson. Any animal that cannot be identified by tattoo, ear tag, or color markings will be ineligible to show.

**Milking Parlor:** The *milking parlor* will operate only with the approval of the *Tennessee State Veterinarian*. At this time, there is a strong possibility that the parlor will remain closed during fair week. Exhibitors of lactating cows should plan to bring their own milking equipment.

**Lactating Cattle:** Cows must be entered as *dry or milking* at the time of registration. Changes will be accepted upon arrival at the discretion of the department chairperson. Review the Tennessee State Veterinarian guidelines in this catalog regarding H5N1 testing and procedures.

**Exhibitor:** The *exhibitor* is defined as the owner recorded on the animal's Registration Certificate. For the *Breeder's Herd* and *Premier Exhibitor* classes, this definition will extend to include the exhibitor and any active 4-H or FFA projects maintained on the exhibitor's dairy.

**Breeder:** The *breeder* is defined as the person recorded on the Registration Certificate as the breeder of the animal. For the *Breeder's Herd* and *Premier Breeder* classes, "bred by" animals must share the same herd prefix or have the same individuals listed as the breeder.

**Show Ring Code of Ethics:** The showing of registered dairy cattle is an important part of breed promotion, merchandising, and improvement programs. It also serves as a key element in the **Purebred Dairy Cattle Association's (PDCA)** mission to stimulate interest and maintain the integrity of registered dairy cattle exhibitions. A copy of the PDCA Code of Ethics is available on our website: [www.appalachianfair.com](http://www.appalachianfair.com).

The PDCA recognizes that proper care, conditioning, and presentation are essential for maintaining a professional and wholesome image of the industry. Exhibitors are expected to display their cattle in a natural, healthy condition and to uphold the highest standards of honesty and integrity.

The following practices are considered **unacceptable and unethical** in the showing of registered dairy cattle:

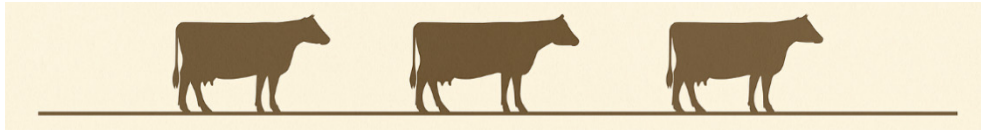
- Misrepresenting the age or milking status of any animal, including exhibiting animals in milk due to unnaturally induced lactation.
- Balancing the udder by any means other than leaving naturally produced milk in one or more quarters.
- Using mechanical or chemical means to set the teats.
- Treating or massaging any part of the body, particularly the udder, with irritants, counterirritants, or any substance intended to alter conformation or animation.
- Feeding, injecting, or applying any substance to minimize cramping or artificially enhance appearance, except through natural exercise.
- Blocking nerves to prevent limping, striking animals to cause swelling, or performing surgery to alter natural contour or appearance. Permitted procedures include the removal of warts, teats, or horns; clipping and dressing hair; and trimming hooves.
- Inserting foreign matter under the skin or altering the color of hair at any location.
- Administering alcoholic beverages as a drench or feed additive.
- Administering any controlled or Unprescribed drug prior to entering the show ring, except for treatment of recognized disease, injury, or for tranquilizing females in heat when necessary for safety.
- Criticizing or interfering with judges, show management, or other exhibitors while in the show ring or engaging in conduct detrimental to the breed or show.

**Check-In & Admission:** Animals must be admitted at Gate 3 and checked in with the Chairperson before 2:00pm on Thursday, August 27. Health papers are required and must be presented to the Chairperson at check-in.

**Care & Housing:** Exhibitors are responsible for the care and bedding of their animals. A tie-space must be secured for each entry. A \$7 per head entry and bedding fee will apply. ### Dairy Showmanship Competition Exhibitor Rules & Information ~ A Century of Family, Farming, and Fun

**Eligibility:** Exhibitors in levels 1-5 include anyone who can exhibit their animal without assistance, is unmarried, and meets the age requirements of their lot division as of the day of the show. The Dairy Showmanship Competition is open to out-of-state exhibitors who also meet these eligibility requirements. Exhibitors must show their own animal, and the animal must be registered and shown in one of the Dairy Show class/lots. If the animal is leased, proof of the leasing agreement must be presented at the time of check-in.

**PDCA:** In keeping with the philosophy of the Purebred Dairy Cattle Association (PDCA), ethical conduct is the personal responsibility of each exhibitor. Any violation of ethical standards is subject to disciplinary action by the respective dairy breed association. PDCA Showmanship Guidelines are posted on our web page: [www.appalachianfair.com](http://www.appalachianfair.com).

**Compliance & Health Regulations:** Exhibitors are subject to all rules and health regulations of: ▪ The Tennessee Department of Agriculture, and ▪ The Appalachian Fair Association as set forth in this catalog.

#### Livestock Senior Showmanship Scholarship Award:

**Scholarship Overview:** The first-place winner in the Senior Showmanship Division will be eligible for a scholarship award of \$1,000. This scholarship is designed to recognize outstanding youth in livestock exhibition and to support their continued education in agriculture and related fields.

**Eligibility & Claim Requirements:** The scholarship must be claimed within two (2) years of the recipient's high school graduation. Recipients must present a current official class roster from an accredited college, university, or technical institute before funds are issued. Previous winners are not eligible to participate again.

**Support & Donations:** Individuals, organizations, and agri-businesses interested in supporting youth in agriculture are encouraged to contribute to the Livestock Scholarship Fund. Donations may be made by contacting: ▪ The Livestock Director, ▪ The Fair Manager, or ▪ The Appalachian Fair Office. The Livestock Senior Showmanship Scholarship is made possible through the generosity of local agri-business sponsors and junior livestock supporters.

### Little Britches Competition Rules & Information ~ A Century of Family, Farming, and Fun

**Eligibility:** This class is open to any child who is not yet old enough to become a 4-H member and who has little to no experience leading an animal. Only individuals designated by the chairperson will be allowed in the show ring with the child. *Pre-registration is not required.*

**Schedule:** Friday, August 28 following the other Dairy Showmanship Show activities with the exception of the Senior Level but will not begin before 6:00pm.

**Divisions:** Three age groups will participate. Age to be determined as of the day of the show. ▪ **Class I:** Children ages 3 and under ▪ **Class II:** Children ages 4-5 years ▪ **Class III:** Children ages 6-8 years showing with assistance.

**Animal Requirements:** All exhibitors must show heifers only. Calves do not need to be owned by the children exhibiting them; however, each exhibitor must make their own arrangements to secure a calf for the event. Calves used in the Little Britches Show must have been exhibited in either the Open or Junior Show. Competition is open to all breeds.

**Awards & Recognition:** All exhibitors will receive a show medallion and a \$2 bill as a participation award.

A five- to ten- minute period will be allowed for “finishing touches” once animals enter the ring. Presence in the show ring constitutes official entry in the class.

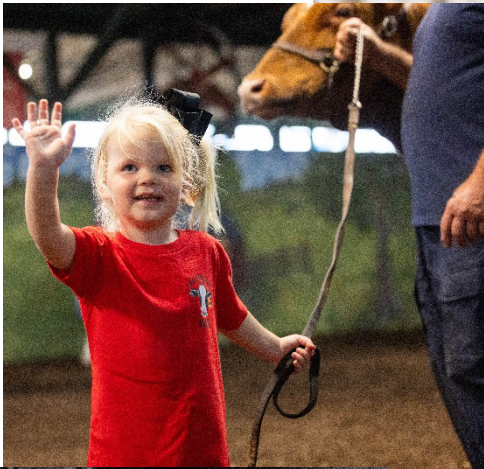
**Judging Criteria:** Entries will be judged on creativity, dairy connection, and overall presentation as follows:

### Open Sheep Show Exhibitor Rules & Information ~ A Century of Family, Farming, and Fun

**Eligibility:** All animals entered must be purebred and registered with their respective breed association in the name of the exhibitor or officially transferred to the exhibitor before August 3. Registration or transfer certificates, properly executed, must be presented to the show chairperson when the sheep arrive at the fairgrounds.

**Exhibit Limits:** Exhibitors may enter no more than two (2) animals per lot. In Lots 7 and 8, exhibitors may enter up to two (2) yearling ewes, which may be entered in the same or different lots.

**Check-in & Admission:** Sheep will be admitted through Gate 2 from 2:00am to 12:00Noon on Thursday, August 27, and must be checked in with the chairperson between 3:00-6:00pm that same day. Livestock exhibitor and vehicle passes will be issued at registration. After this time, all exhibitors must present both passes to enter the fairgrounds or any parking area.

**Breed Requirements:** A minimum of ten (10) sheep and two (2) exhibitors/farms per breed class is required for a breed show to occur. If this minimum is not met, all animals will show as Any Other Breed (AOB).

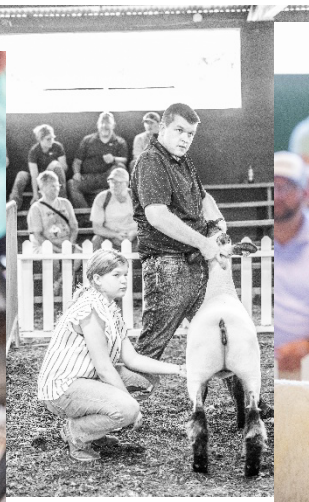
**Animal Age Requirements:** Exceptions to age classification may be made if an exhibitor wishes to enter a younger animal in an older age class; however, older animals may not be entered in a younger class than their birthdate permits.

**Stalling: Care & Housing:** Exhibitors are responsible for the care and bedding of their animals. A \$5 per head entry fee will apply to all Open Sheep Show animals. Each will receive a **\$250 Cash Premium award**. A \$60 Premium **Adult Herdsman Award** will also be presented to recognize excellence in herd management, presentation, and showmanship.

### Junior Sheep Show Exhibitor Rules & Information ~ A Century of Family, Farming, and Fun

**Eligibility:** Junior Show exhibitors include anyone who can exhibit their animal without assistance, is unmarried, and is 21 years of age or younger as of January 1 of the current year. The Junior Show is open to out-of-state exhibitors who meet these same eligibility requirements. All animals entered must be purebred and registered with their respective breed association in the name of the exhibitor or officially transferred to the exhibitor before August 3. Registration or transfer certificates, properly executed, must be presented to the show chairperson when the sheep arrive at the fairgrounds. Lease contracts will be accepted at the time of entry, provided they were legally executed on or before July 1 of the current year. Leased animals are not eligible to compete in the Senior Showmanship Division unless proof of lease is provided.

**Exhibit Limits:** Exhibitors may enter no more than three (3) animals per lot, with the exception of Lots 7 and 8, where exhibitors may enter a total of two (2) yearling ewes. These entries may be in the same or different lots.

**Check-in & Admission:** Sheep will be admitted through Gate 2 from 2:00am to 12:00Noon on Thursday, August 27 or from 2:00am to 12:00Noon on Friday, August 28, and must be checked in with the chairperson between 3:00-6:00pm that same day. Livestock exhibitor and vehicle passes will be issued at registration. After this time, all exhibitors must present both passes to enter the fairgrounds or any parking area.

**Breed Requirements:** A minimum of ten (10) sheep and two (2) exhibitors/farms per breed class is required for a breed show to occur. If this minimum is not met, all animals will show as Any Other Breed (AOB).

**Animal Age Requirements:** Exceptions to age classification may be made if an exhibitor wishes to enter a younger animal in an older age class; however, older animals may not be entered in a younger class than their birthdate permits.

**Stalling: Care & Housing:** Exhibitors are responsible for the care and bedding of their animals. A \$2 per head entry fee will apply to all Open Sheep Show animals. Fees must accompany pre-registration forms, either by: ▪ Hand-delivering entries with a check to the Fair Office, or ▪ Paying online through the invoice issued at registration. Sheep stalling will be assigned as follows: three (3) lambs, three (3) rams, or two (2) yearlings per pen. Additional pens may be purchased if needed at a fee of \$10 per pen. Moving or altering pen assignment signs will result in disqualification.

**Tents:** Tents and personal belongings may not block or restrict aisles or barn entryways. A limited number of designated spaces will be available and assigned. Reservations for tent spaces begin June 1 and may be made by calling the Fair Office. Tents will not be allowed in the wash rack area prior to 12Noon on Thursday, August 27, or after 6:30pm on Saturday, August 29 to allow trailers to use the alley for loading and unloading.

**Proper Attire:** Proper dress must be followed in the show ring: shirts tucked in, wit jeans, or slacks and shoes. Boots are strongly recommended.

**Awards & Recognition:** At the conclusion of the Junior Sheep competitions, a **Supreme Champion Ewe** and **Supreme Champion Ram** will be selected from the Grand Champion winners in each class. Each will receive a **\$150 Cash Premium award**. A \$60 Premium **Junior Herdsman Award** will also be presented to recognize excellence in herd management, presentation, and showmanship.

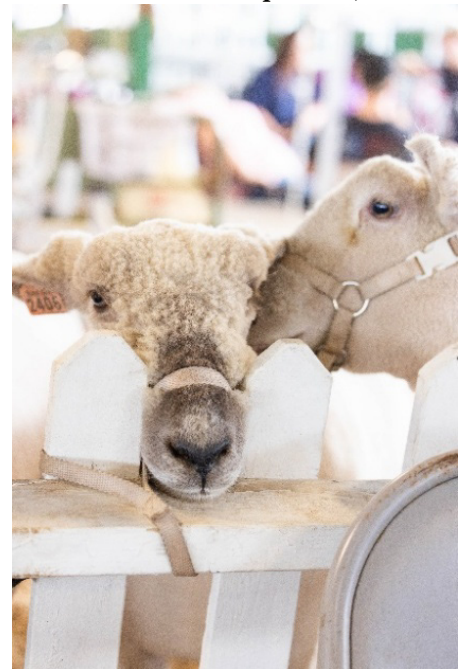

## Sheep Breed Classification Standards ~ A Century of Family, Farming, and Fun

All animals must meet their respective breed or type standards to be eligible for that particular breed division. Classification is determined through a breed sift conducted during show check-in, where a qualified breed classifier evaluates each animal for conformity to breed standards. In Market Lamb and Commercial Ewe competitions, any animal found not meeting breed standards will be assigned to the Blackface Crossbred Division. All classification decisions are final.

- **Southdowns:** Three (3) of the following will result in disqualification: Solid white hair on muzzle; Pink nose; Excessive white on face, ears, or legs; Completely slick ears; Pink or striped hooves; Black spots in the fleece, not hide; Open poll on the head; speckled face or legs. Absolute disqualification: Solid black color; Horns or solid scurs; Double muscled.
- **Dorsets:** Three (3) of the following will result in disqualification: Dark-colored spots in the hair or wool; Large drooping ears; Fine-textured, silky hair covering; Absence of hair in typical areas; Dark septum between nostrils; Dark lining of nose or mouth. Absolute disqualification: All-black, colored, or spotted (Holstein-type) lambs.
- **Hampshires:** Three (3) of the following will result in disqualification: Broken wool cap; Very fine or thin hair on face or legs; Scurs; More than 25% white hair on jaw or legs; Excessively dark or blue hide; Inadequate wool on head and legs; or brockle-faced. Absolute disqualification: Horns; Lack of wool cap; Steep hip or double-muscling tendency.
- **Suffolks:** Three (3) of the following will result in disqualification: Non-black hair on head, ears, or legs; Wool on head; Wool below hock and knee; Short or non-bell-shaped ears. Absolute disqualification: Horns.
- **Tunis:** Three (3) of the following will result in disqualification: White blaze below eye ridges; White or black face or legs; Mottled or white socks on legs; Non-pink nose or tongue; Wool containing colored fiber. Absolute disqualification: Horns or scurs.
- **Shropshire:** Three (3) of the following will result in disqualification: Broken wool cap; Coarse or drooping ears; Coarse or Roman nose; White on face, ears, or legs; Legs bare of wool below knees and hocks; Black armpits or black spots in skin or wool. Absolute disqualifications: Horns; Lack or wool cap; Steep hip or double-muscling tendency.
- **Katahdin:** Three (3) of the following will result in disqualification: Scurs; Short, barrel, or extended body; Sway or humped back; Large head or parrot mouth; Long thin neck; Short, over-long, or sickle-hocked legs. Absolute disqualifications: Weak or fallen pasterns; Docked tail; Shoulders wider than hindquarters; Horned ewes; Rams lacking a mane.
- **Natural Color:** Sheep must exhibit natural colored wool in at least 35% of the fleece (excluding face and legs). No specific color, solid or variegated, pale or dark, is required and all should be considered equal. White is the absence of color and natural colored sheep do not have more than 65% white wool. Use of artificial coloring must be grounds for disqualification. Sheep will be judged 60% wool for handspinning quality conformation and 40% for soundness and musculature (NCWGA).
- **White-Face Crossbred:** Must be the offspring of at least one white-face parent or a white-face cross ram and ewe. Must have predominantly white hair (approximately 50%) on head and ears, with visible speckling on ears, face, jaw, flank, or legs, or other piebald markings.
- **Blackface Crossbred Division:** Includes any animal that does not conform to the specific standards of recognized breeds but exhibits a predominately black face, ears, and legs. These animals are typically the result of crossbreeding programs and will be judged on overall market quality, including muscle, balance, structure, and finish rather than breed characteristics.
- **Hair Sheep (Market/Commercial):** Evidence of hair sheep breeding will show in the Crossbred Hair Division.

**Exhibit Entries:** Applications for entry must be completed on the official entry form or online at [www.appalachianfair.com](http://www.appalachianfair.com). All entries and payments must be received by August 3.

**Check-in & Registration:** Commercial Ewes will be weighed between 3:00-6:00pm on Friday, August 28. Animals will be admitted through Gate 2 to the fairgrounds and must be checked in with the chairperson between 3:00-6:00pm that day.

**Eligibility:** All General Junior Show Rules apply regarding registration, entry fees, and fair entry. This class is open to non-registered ewes of any breed or combination of breeds. Only weaned ewes may be shown. Each ewe must have yearling teeth and may not have two-year teeth – all animals will be mouthed to determine age. **Junior Market Lamb Exhibitor Rules & Information ~ A Century of Family, Farming, and Fun**

**Exhibit Entries:** Applications for entry must be completed on the official entry form or online at [www.appalachianfair.com](http://www.appalachianfair.com). All entries and payments must be received by August 3.

**Check-in & Registration:** Market Lambs will be weighed between 3:00-6:00pm on Friday, August 28. Animals will be admitted through Gate 2 to the fairgrounds and must be checked in with the chairperson between 3:00-6:00pm that day.

**Eligibility:** All General Junior Show Rules apply regarding registration, entry fees, and fair entry. The Junior Market Lamb Show is open to non-registered ewes or wethers of any breed or combination of breeds. Ear tag numbers should be used in place of names on the entry form. Lambs must have their lamb teeth and be mouthed to determine age. Both wether and ewe lambs are eligible to show. Lambs must be owned and under the care and management of the exhibitor before August 3.

**Entry Fees:** Entry fees for this department are \$2 per head. Fees must accompany the pre-registration forms, either by hand-delivering entries with a check or by paying online through the invoice issued at registration. Each exhibitor must also have a valid exhibitor pass.

**Weight Classes:** Lambs must weigh a minimum of 75 pounds to be exhibited. There is no maximum weight. Lambs will be divided into equal weight classes determined by breed influence (e.g., Whiteface Cross, Blackface, Hair). All lambs are required to have an ear tag and an official veterinary health certificate.

**Show Limitations:** Exhibitors may show no more than six (6) animals in the Junior Market Lamb Show, including all classes and lots. Lambs shown in the Junior Market Lamb Show are not eligible to participate in either the Open or Junior Registered Sheep Shows or the Junior Commercial Ewe Show.

**Premiums & Awards:** Each class will award a Champion and Reserve Champion, who will then compete for Overall Grand Champion and Reserve Grand Champion. Premiums and awards will be distributed at the discretion of the Livestock Committee.

**Care & Bedding:** Exhibitors are responsible for providing their own feed, bedding, and equipment, and for maintaining their animals in assigned spaces throughout the event. Animals must receive proper care, and exhibitors must show their own animals. Pens must remain clean and orderly at all times.

**Exhibitor Attire:** Proper dress is required in the show ring: shirts tucked in, with jeans or slacks and shoes; boots are strongly recommended.

**Compliance & Health Regulations:** Judges' and Livestock Committee decisions are final. Exhibitors are subject to all rules and health regulations of: ▪ The Tennessee Department of Agriculture, and ▪ Open & Junior Sheep Show Rules ▪ The Appalachian Fair Association as set forth in this catalog.

**Eligibility:** Exhibitors in levels 1-5 include anyone who can exhibit their animal without assistance, is unmarried, and meets the age requirements of their lot division as of the day of the show. The Sheep Showmanship Competition is open to out-of-state exhibitors who also meet these eligibility requirements. Exhibitors must show their own animal, and the animal must be registered and shown in one of the Sheep Show class/lots. If the animal is leased, proof of the leasing agreement must be presented at the time of check-in.

**Conduct:** Ethical conduct is the personal responsibility of each exhibitor. Any violation of ethical standards is subject to disciplinary action by the Livestock Committee.

**Compliance & Health Regulations:** Exhibitors are subject to all rules and health regulations of: ▪ The Tennessee Department of Agriculture, and ▪ The Appalachian Fair Association as set forth in this catalog.

#### Livestock Senior Showmanship Scholarship Award:

**Scholarship Overview:** The first-place winner in the Senior Showmanship Division will be eligible for a scholarship award of \$1,000. This scholarship is designed to recognize outstanding youth in livestock exhibition and to support their continued education in agriculture and related fields.

**Eligibility & Claim Requirements:** The scholarship must be claimed within two (2) years of the recipient's high school graduation. Recipients must present a current official class roster from an accredited college, university, or technical institute before funds are issued. 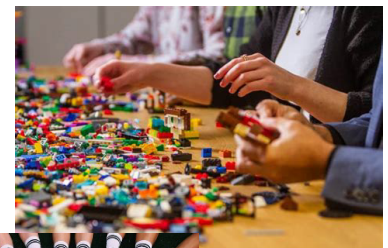

### HOW TO SUBMIT AN ONLINE ENTRY

6. Click 'Add New Exhibit' link.
7. Choose the department you are entering and then the class.
8. For Livestock entries, you will be asked to enter additional information about your entries (such as breed, birthdate, animal name, registration number, etc.). For other types of entries, simply choose the lot that you are entering.
9. You will be asked to confirm that your entry is correct.
10. You can then submit any additional entries. A list of your entries will be displayed.
11. Once all of your entries have been submitted, click on the 'checkout' link.
12. If an entry fee is required – Livestock entry fees – you will receive an online payable invoice after your entries have been accepted. Livestock exhibitors may request to purchase exhibitor passes as well.

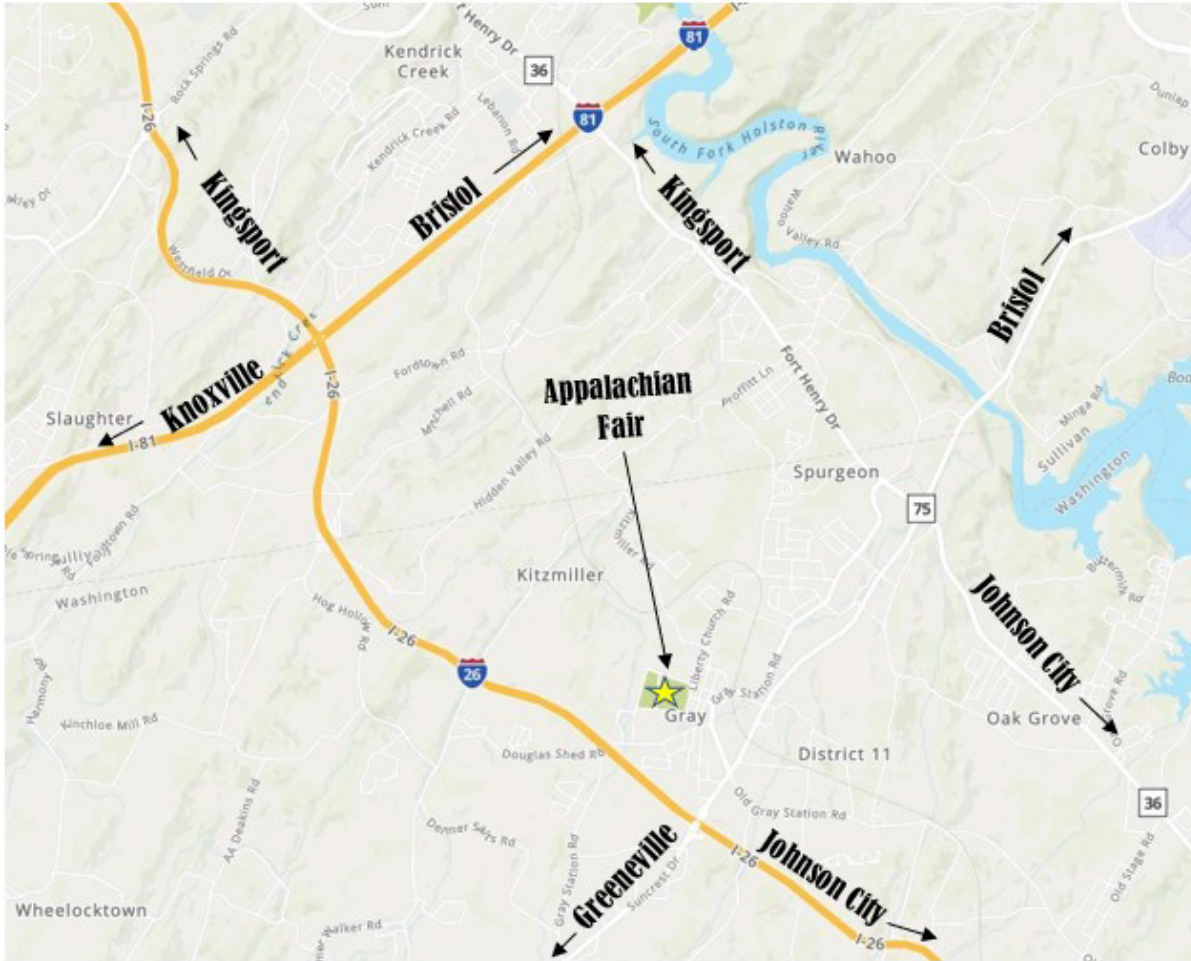
