Entry Deadlines & Submission:

Primary Deadline: Completed entry forms must be received in the Appalachian Fair Office by 12:00Noon on Thursday, August 13.

Extended Deadline (If Space Allows): If fewer than 25 contestants per class are registered, completed entry forms with payment will be accepted through 12:00Noon on Saturday, August 22, or until the 25-contestant maximum per division is reached. Late entrants may not have an opportunity to practice before the contest.

For faxed/emailed entries, invoices will be sent within 24 hours to the email address provided on the entry form. Contestants are not added to the roster until forms and payments are complete.

Rehearsals:

Saturday, August 15 & Saturday, August 22 | Museum Stage

- **10:00am (Sharp)** – Wee Miss, Tiny Miss, & Little Miss
Wee Miss & Tiny Miss contestants must always be accompanied by one (1) adult. (Only one (1) adult).
- **12:00Noon (Sharp)** – Pre-Teen Miss & Teen Miss

Attendance is strongly encouraged for the contestant's benefit.

Entry Fee:

- A **\$50 non-refundable entry fee** must accompany the registration form.
- Entry forms will not be processed – and spots will not be held – until payment is received.
- Unpaid entry applications will only be held for five (5) days before being destroyed.

Age Divisions:

- **Wee Miss – Division I:** Ages 2-3 **
- **Tiny Miss – Division II:** Ages 4-6 **
- **Little Miss – Division III:** Ages 7-9
- **Pre-Teen Miss – Division IV:** Ages 10-12
- **Teen Miss – Division V:** Ages 13-15

**** Wee Miss and Tiny Miss contestants MUST always be accompanied by one (1) adult.**

Age division placement is determined by the contestant's age on the day of the contest.

Contest Rules & Guidelines:

- Contestants may wear a dress of their choice. No exposed midriffs.
- Judging: 75% beauty ▪ 25% personality. Judges' score sheets are not released to contestants or families.
- **People's Choice Award:** presented in each division. Cash only will be accepted for votes.
- Proof of age may be required upon request.
- All participants must follow Pageant Committee guidelines.
- First-place winners may not compete again in the same age division.
- 2026 Queens will crown the 2027 Winners and are not eligible to re-enter in 2027.
- Get your form in early! Download and complete the form digitally for clear, accurate information. Contestants **first to enter will be the last to compete** in their age division. If you mail applications, call the Fair Office at 423.477.3211 to confirm receipt.

Awards: A Queen and Four Runners-Up will be selected in each division.

- Queens receive: trophy, crown, and wrap-around sash
- All other contestants receive: trophy

 - Bring to practice on **Saturday, August 22**, or
 - Deliver to the Appalachian Fair Office
 - No frames of glass!
- Write name, age, address, and phone number on the back of the photo.
- A **\$10 non-refundable fee** must accompany the entry.
- **ABSOLUTE DEADLINE: 12:00Noon on Saturday, August 22** – No photos accepted after this date.
- Photos must be picked up on the night of the pageant.
