

# **APPALACHIAN FAIR'S FAMILY FACEOFF**

**WEDNESDAY, AUGUST 20, 2025 @ 7PM**  
**on the Museum Stage**



Family teams of five (5) each face off against each other in a one question match. Teams advance through the game by winning their match and gaining the high score. The team with the highest score at the end of the game wins. The teams will play in a “round robin” system that will be set-up before the competition begins. Family teams must be in the audience and ready to go when their teams are called.

## **Match Rules:**

1. Each team chooses a player for the one-on-one Face Off. Each round begins with a one-on-one Face Off as a player from each team tries to take control of the question by giving the more popular (not necessarily number one) answer.
2. After the Host reads aloud the question, either of the two one-on-one players will raise their hand/press the buzzer to respond. The Host will decide who responded first. The player then must answer the question immediately. If a player fails to give an answer immediately, he will lose his turn. If his answer is the top answer on the board, he may choose to pass or play. If the one-on-one player gives an answer that is not one of the listed top responses, the player on the opposing team gets to answer the question. If both players give an answer that isn't on the survey, the second player from each team attempts to answer the question in the same order as the first two one-on-one players.
3. Correct answers will be displayed on the Survey Answer Board along with their point values. If the answer is not the top answer on the board, the opposing team is given the chance to give an answer. If their answer is place higher, they will get the chance to pass or play. If their answer is lower, control goes back to the first team.
4. The team that wins the one-on-one Face Off may play the question or pass the question to the other team. The team playing the question becomes the 'controlling team.' Players on the controlling team take turns guessing the answers to the question. Players cannot help each other answer the question.
5. The Host will announce how many answers there are to the survey. When a player gives a correct answer, the Host announces the answer, placement on the scoreboard and the corresponding points for that answer. When a player/team gives an incorrect answer or takes too long to give an answer, it will count as a strike. The Host will place an 'X' in one of the three strike boxes for that team.
6. The controlling team that gives all the remaining answers to the Question without getting three strikes, will have the points totaled and added to the scoreboard under their name. If the controlling team gets three strikes before all the remaining answers are revealed, the opposing team will have a chance to steal the points by working as a team to determine a missing/winning response to be presented by their team Captain. If their answer is not on the board, the controlling team will get the revealed points.
7. At the end of the night, the team with the most points wins 1<sup>st</sup> place. Second highest score wins 2<sup>nd</sup> place, and third highest score wins 3<sup>rd</sup> place. Additional prizes will be announced that night.

Prizes awarded:

1<sup>st</sup> Place: \$500

2<sup>nd</sup> Place: \$250

3<sup>rd</sup> Place: \$100
